

**ANNEX 11-A**

**SCHEDULE OF MEXICO’S COMMITMENTS TO SINGAPORE**

The following sets out Mexico’s commitments in accordance with Article 11.4 (Grant of Temporary Entry) in respect of the temporary entry of business persons.

<b>Description of Category</b>	<b>Conditions and Limitations (including length of stay)</b>
<p><b>A. Business Visitors</b></p> <p>Mexico extends its commitments under this category to Singapore’s under the heading “Business Visitors” or “Short Term Business Visitors”.</p>	
<p><u>Definition:</u></p> <p>Applicable to the foreign nationals seeking to enter into the country on a temporary basis, and intending to:</p> <ul style="list-style-type: none"> <li>(a) establish, develop or manage a foreign capital investment;</li> <li>(b) provide specialised services, including after-sale or after-lease services, previously agreed or as referred to in a contract of transfer of technology, patent and trademark, for the sale of machinery and equipment, technical training of personnel or any other production process of an established company in Mexico; or</li> <li>(c) attend business administration meetings, conferences, trade fairs, and performing management or executive duties in a company or its subsidiaries or affiliates that are established in Mexico.</li> </ul> <p>The source of income for the proposed business activity is outside Mexico and the business person’s principal place of business and the actual place of accrual of profits, at least predominantly, remain outside Mexico.</p>	<p>For the purposes of temporary entry, Mexico shall grant a stay up to 180 days.</p>

<p><b>B. Intra-Corporate Transferees</b></p> <p>Mexico extends its commitments under this category to Singapore that has made commitments under the heading “Intra-Company Transferees” or “Intra-Corporate Transferees”. Mexico shall grant temporary entry and provide a work permit or work authorisation to spouses of Intra-Company Transferees of Singapore which has also made a commitment in its Schedule for spouses, and will not:</p> <ul style="list-style-type: none"> <li>(a) require labour certification tests or other procedures of similar intent as a condition for temporary entry; or</li> <li>(b) impose or maintain any numerical restriction relating to temporary entry.</li> </ul>	
<p>Definition:</p> <p>For purposes of this category:</p> <ul style="list-style-type: none"> <li>(a) <b>Executive</b> means a business person within an organisation who primarily directs the management of the organisation and exercises wide latitude in decision-making;</li> <li>(b) <b>Manager</b> means a business person within an organisation who primarily directs the organisation or a department or subdivision of the organisation, supervises, and controls the work of other supervisory, professional or managerial employees;</li> <li>(c) <b>Specialist</b> means a business person who possesses specialised knowledge of the company’s products or services and its application in international markets, or an advanced level of expertise or knowledge of the company’s processes and procedures.</li> </ul>	<p>For the purposes of temporary entry, Mexico shall grant a stay of one year, which may be extended three times for each and equal period of time.</p>

<p><b>C. Investors</b></p> <p>Mexico extends its commitments under this category to Singapore that has made commitments under the heading “Investors”, “Independent Executives” or “Persons Responsible for Setting up a Commercial Presence”.</p> <p>Mexico shall grant temporary entry and provide a work permit or work authorisation to spouses of Investors of Singapore which has also made a commitment in its Schedule for spouses, and will not:</p> <ul style="list-style-type: none"> <li>(a) require labour certification tests or other procedures of similar intent as a condition for temporary entry; or</li> <li>(b) impose or maintain any numerical restriction relating to temporary entry.</li> </ul>	
<p>Definition:</p> <p>For purposes of this category:</p> <p>It is applicable to the foreign nationals seeking to enter into the country on a temporary basis or that are already in the country and intending to:</p> <ul style="list-style-type: none"> <li>(a) know different investment alternatives;</li> <li>(b) perform a direct investment or supervise such investment;</li> <li>(c) represent a foreign company or perform business transactions; or</li> <li>(d) develop, administer or provide advice or key technical services to the operation of an investment to which the business person or the business person’s enterprise has committed, or is in the process of committing, a substantial amount of capital, in a capacity that is supervisory, executive or involves essential skills.</li> </ul>	<p>For the purposes of temporary entry, Mexico shall grant a stay of one year, which may be extended three times for each and equal period of time.</p>

Professionals and Technician-Professionals</b></p> <p>Mexico extends its commitments under this category to Singapore that has made commitments under the heading “Professionals”, “Independent Professionals”, “Professionals and Technicians”, “Professionals and Technician-Professionals, “Technicians”, “Contractual Service Suppliers” or “Qualified Professionals”, limited to the same occupations, activities, professions or sectors committed by Singapore. Mexico shall grant temporary entry and provide a work permit or work authorisation to spouses of Professionals and Technician-Professionals of Singapore which has also made a commitment in its Schedule for spouses, and will not:</p> <ul style="list-style-type: none"> <li>(a) require labour certification tests or other procedures of similar intent as a condition for temporary entry; or</li> <li>(b) impose or maintain any numerical restriction relating to temporary entry.</li> </ul>	
<p>Definition:</p> <p>1. For purposes of this category:</p> <ul style="list-style-type: none"> <li>(a) <b>Professional</b> means a business person who is engaged in a specialty occupation requiring: <ul style="list-style-type: none"> <li>(i) theoretical and practical application of a body of specialised knowledge, and</li> <li>(ii) attainment of a post- secondary degree for entry into the occupation;</li> </ul> </li> <li>(b) <b>Technician Professional</b> means a professional who has: <ul style="list-style-type: none"> <li>(i) theoretical and practical application of a body of specialised knowledge, and</li> <li>(ii) attained a post-secondary technical degree, for entry into</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>1.
